Stallion owners who donate services will have the privilege of participating in the Select Stallion Futurity, subject to the rules and conditions, along with the purchasers of the stallion fees. The Stallion Owner will have the option of paying the balance of any unpaid fee(s) of his stallion(s) to maintain eligibility in the auction. The stallion owner will then have three eligible entries.

### MARE OWNER: The mare owner agrees to purchase the above breeding service from the Select Stallion Auction.

**Payment Record:**

At the time of purchase, the mare owner will sign all copies of the agreement—one will be retained by the mare owner, one by the Select Stallion Auction secretary, and one will be sent to the stallion owner as proof of who purchased the stallion's service. It is the mare owner's responsibility to have verified transported semen agreements before the auction. Rule sheets are available from the Select Stallion Futurity Secretary and on the club website regarding the Select Stallion auction and futurity. All stallion fees and contracts purchased must be paid up and in good standing on all Select Stallion Auction contracts to maintain eligibility to show in resulting futurities. Interest may be added to past due accounts. Stallion owner has the option to purchase their Stallion if the purchase price is not paid in full by September 1st of the year following the auction year. **Stallion & Mare owner responsibilities: Nominate your mare, DUE ON DECEMBER 31st and inform futurity secretary of foal's date of birth, sex & registered name (if registered).**
